Dietary Requirements

Please advise us on booking if you or any of your group has any special dietary requirements. 300 Acres will make all efforts to meet any dietary requirements where possible.

**Please note that dishes are prepared in a kitchen that handles milk, egg, soy, seafood (including crustaceans), peanuts, sesame seed, tree nuts, gluten (from wheat, rye, barley, oats and spelt).

Payment

Final numbers and full pre-payment for food is required for all group bookings 3 days prior to your booking. Please note should your numbers drop below the final numbers given 3 days prior there will be no refund. No split billing. No reallocation of Money.

Final Numbers and Deposits

For bookings with numbers between 16 and 30 Pax, (not including children), who choose from the All- Day dining menu, there is a non-refundable deposit of \$25.00 per person to be paid to secure the booking.
